The NYSUT Member Benefits Corporation's endorsed Cambridge Credit Counseling program can assist NYSUT members with better understanding their student loan re-payment options and/or debt consolidation.

If members attend a free seminar, Cambridge will waive the \$15 fee typically charged to download the member's student debt to a portal. A portal report with the specific loan data is sent to a counselor who can then provide a free one-on-one counseling session and a complete review of finances.
